Excellence needed to provided ethical care

Dear *SaskEthics* Readers,



I have found myself in a few very challenging situations over the past few months that have reminded me of the importance of striving for excellent care. The situations have largely concerned patients who needed help, but some bureaucratic or legal obstacle prevented them from receiving care. The obstacles were diverse, and included migration, lack of an assigned proxy, and, in some heart wrenching cases, family who did not have the best interests of the patient at heart.

What I noticed in these situations is that the outcome we achieved was directly tied

to the lens through which we viewed the situation. For example, when our care team approached a concern by first asking, “What do we need to do to avoid getting sued?” we often arrived at a very sterile answer that left us unsatisfied. When we expanded our search to ask, “What does the healthcare system say we owe this patient?” we got a little further into providing the type of care that we could be proud of, but it still felt lacking.

It’s not until we started asking ourselves bigger questions, such as, “what needs to change in the system for us to provide excellent care?” that we really got to where we needed to be. Providing ethical care demands that we go beyond what is required or expected of us, and strive for something excellent.
